

- III. Roll Call
 - a. Present: Tim Yocum, RJ Dunavan, Britton Luther, and NVHS Student Carter Edney
- IV. Approval of Minutes
 - a. A motion was made by Luther to approve the March 15th meeting memorandum, and it was seconded by Dunavan. All in favor, motion carried
- V. Approval of Claims
 - a. A motion was made by Dunavan to approve the March 25th, April 1st, and April 15th claims, and it was seconded by Yocum. Luther opposed. Motion carried.
- VI. Approval of Payroll
 - a. A motion was made by Dunavan to approve the April 1st, and April 15th payroll, and it was seconded by Luther. All in favor, motion carried.
- VII. Treasurer's Report
 - a. Treasurer, Florinda Pruitt was present to present the Treasurer's Report for the month of March.

- IX. Open Issues
 - a. COVID Update
 - i. Yocum read the COVID Update.
 - b. Vermillion Rise
 - i. Bob Grewe was present to speak about the Mushroom Hunt, a natural gas proposition at their next meeting, RFQ on the administration building, Shell building, IDEM extension on agreed order, and he gave an update on the Solar Project.
 - c. VTA (Vermillion Trails Alliance)
 - i. Tom Milligan was present to speak about the outcome of the Victory Race.
 - d. Jail
 - i. Luther gave update on jail project.
 - e. Ambulance Committee
 - i. Yocum reads the nominees he recommends aloud. Luther makes a motion to approve the nominees for the Ambulance Committee, and it was seconded by Yocum. Dunavan opposes. Motion carried.

 - a. USI – Brandon Adamson Health Insurance
 - i. Brandon Adamson was present to give a quick recap about Health Insurance and to answer any questions. A motion was made by Dunavan to approve the renewal of insurance and \$1,000 HSA Employer donation, and it was seconded by Luther. All in favor, motion carried.

 1. A motion was made by Dunavan to use the ARP State and Local Fiscal Recovery Funds as loss revenue because the county is

eligible as a Tier 5, and it was seconded by Luther. All in favor, motion carried.


- ii. Economic Development




