VII. Public Comment

- Scott Peebles the Helt Fire Chief comes to talk about the locations on the current ambulance facilities. If the ambulance has a run and it is North of 36 then the North ambulance comes to the call if the call is South of 36 then the South ambulance comes. When they need the North ambulance the run times are between 25 30 minutes. If the South is busy and the North has to come then it takes them about 40 45 minutes depending on the location. Peebles feels the county needs a third ambulance which would be located somewhere in the middle of the county.
- Doug Bohannon who lives in Universal. He feels that the county needs to have a safety contractor come in and evaluate what safety equipment and what we need to do to protect our county from the CO2 and how much it is going to cost so the county can be prepared accordingly.
- Whitney Boyce comes to ask when and if all the questions and comments that the county had received would be available for review. The Commissioners stated that yes they will be but they don't have a time frame of when that will happen just yet.

VIII. New Issues

- a. Perrysville Town Park
- Luther states they had an inquiry from the Perrysville Township Trustee regarding the Perrysville park. Luther states that this is an ongoing review, he wants to make sure the county has all the proper paperwork for all the county parks.
- b. Ambulance Buildings Proposal: Mark O'Heir
- O'Heir states that the ambulance committee is going to be meeting next week. After the council meeting on Monday, the council is wanting the committee to get more definitive numbers on how much it is going to cost to build the facility. O'Heir does state that they are having someone draw a floor plan. Dunavan states that he agrees with Peebles but that right now priority one is to get the buildings built and get the response times back down. Luther also states that others on the ambulance committee have also voiced the same concerns as Peebles.
- c. Mitigation Proposal Plan: Mark O'Heir
- O'Heir states that he is working on getting the mitigation proposal plan contract updated. The county received a grant from the state for \$20,304.00. The county has to match in kind \$6,786.00. The county will have five years to mitigate issues that are known issues which are weather related.

- Luther states that they were going to try and use the \$500,000.00 for the culvert over 63 by Cayuga however the CCMG is only for roads that are only established. He also states that Klyaic is working on getting the roads together that for the CCMG 2024-02 that is
