 - Luther makes the motion to approve the 12.22.23 claims. Dunavan seconds the motion. All in favor, motion carried.
- VI. Approval of Payroll for 12.22.23
 - Dunavan makes a motion to approve the 12.22.23 payroll. Luther seconds the motion. All in favor, motion carried.

VII. Public Comment

- Ron Mack comes to request a laptop so that when he is out in the field he can use the county GIS Map on the laptop since it isn't mobile friendly. He also talks about regulated drains and gives copies of letters of support from Soil and Water and the Farm Bureau. The Commissioner's request the surveyor to come to the next meeting.

VIII. New Issues

- a. Vermillion County 2023 Certificate Sale Calendar Approval
 - i. Resolution 2023-21
- Stephanie Simpson comes to explain what the certificate sale is and how it works. In September, the county had a tax sale. Out of the list of properties, 35 of them, didn't sell. Those are now being put in the certificate sale, which will take place in 2024. The certificate sale also has a redemption time frame of 120 days instead of a year. Dunavan makes the motion to approve the 2024 Certificate Sale contract with SRI. Luther seconds the motion. All in favor motion carried. Donavan makes the motion to approve the Resolution 2023-21, establishing the intent to conduct a Commissioner Certificate Sale. Luther seconds the motion. All in favor, motion carried.
- b. County Insurance Renewal: George Smith
- George explains all the insurance renewal documents. Luther makes the motion to approve the insurance renewals for the county. Dunavan seconds the motion. All in favor, motion carried.
- c. Request for Change of Zoning Classification: Penney Carpenter & Clate & Tammy Sanquenetti
- Carpenter comes to explain that the Sanquenetti's is wanting to change the zoning from having Suburban Residential (S1) to a (B2) General Business zoning area. The location is in St. Bernice. Dunavan makes the motion to approve the zoning change petition 23-03 with the amendment to allow only general business. Luther seconds the motion. All in favor, motion carried.
- d. Illiana Contract Extension Approval
- Luther makes the motion to approve the Illiana Ambulance Contract until June 30th 2024. Dunavan seconds the motion. All in favor, motion carried.
- e. New Ambulance Facilities
- Yocum states that the county has been working on a new ambulance facility for the county. It will be located on the East side of the road up by Perrysville.
- f. Ground Water Withdraw
- Luther states that he would like to see some action taken at the county level since the state hasn't taken any action besides monitoring large withdrawals through DNR. Dunavan explains that this is in regards to the Lebanon project with the Wabash River. Dunavan also explains that the Indiana Economic Development is kind of picking areas to do large projects in, however Lebanon doesn't have enough water, so they have been talking about pumping water from the Wabash up to Lebanon. He also states that other

counties bordering the Wabash have made either an ordinance or resolution against doing this, he would like out county do to the same. Yocum states that he would like this added to the next agenda and would like to come back with more information.

- Luther makes the motion to approve the Septic Ordinance 2023-07. Dunavan seconds the motion. All in favor, motion carried.

- Luther makes the motion to approve the 2024 Holiday calendar. Dunavan seconds the motion. All in favor, motion carried.
- c. Board Appointments for 2024
 - i. REDI Grant Appointment
 - Yocum states that Vermillion County has an open seat on the REDI Grant Appointment. Rennel's comes to talk about what the REDI Grant. Luther makes the motion to approve Bill Rennels as the appointment for the REDI Grant board. Dunavan seconds the motion. All in favor, motion carried.

- d. DNR Water Site up North
- Dunavan states that the survey has been completed for the DNR water site up north. He states that they are wanting a name for the water site, they would prefer not to use someone's name.
- e. Vermillion County Bicentennial
- The date is February 1, 1824. Yocum also states that he has met with Steve Axtell and Mr. Henry who informed him that the State of Indiana is looking for someone to be the new county historian, the State had to have the paperwork by December 10th. Yocum explains that he wrote a letter and sent in the appropriate paperwork to appoint George Sanquenetti as the historian. Yocum also states that they are going to do something for the Bicentennial, they just don't know the scope yet. Luther states that he will be making that announcement at the next meeting.
- f. IT Contract
- Luther states that he was hoping to have an IT Director for the county. He states that if
 anyone is interested in the position to contact him. Luther makes a motion to approve the
 2024 IT Contract with EAS. Dunavan seconds the motion. All in favor, motion carried.
- g. Opioid Settlement for Peer Court
- Dunavan makes a motion to approve the councils request to use the Opioid Settlement funding to go towards Peer Court. Luther seconds the motion. Luther then asks if they are assigning the next 5 to 10 years of opioid settlement money to fund Peer Court? He states

that he isn't in favor of assigning all the money to the program, he feels it should be an annual request. Dunavan states that he is fine with approving all the money going towards Peer Court. Yocum calls for a vote, Yocum and Dunavan approve, Luther opposes, he wishes to approve the opioid settlement yearly. Motion passed.
