  - a. Mainstream Fiber: Scott Rudd, Scott Rudd, Fred Price
  - They would like to bring mainstream fiber to Vermillion County. This company focuses on rural broadband for Indiana. They are also an Indiana company. Indiana based focused on broadband. They are currently looking at about 18,000 addresses that they could help within our county get internet. They also believe that they could possibly add more addresses after the first round of the BEAD program. They state that the next 60 90 days are going to be very crucial days in order to get the money from the State for this program. Biggest part is a letter of support for this project.
  - b. Soil & Water/Public Defender Signs
  - Luther is going to work with Schideler to get appropriate signage for the annex that states who is in the building.
  - c. Codification of County Ordinance (American Legal Publishing (amleagal.com)
  - Luther states that the codification of county ordinances would be a way to have access to all the counties ordinances in one area so that it would be easier to look to see if a "county law" has already been created for something in the past.
