  - a. VTA (Vermillion Trails Alliance)

  - a. Covered Bridge Certification Request
    - A motion was made by Luther to approve the covered bridge certification request, and it was seconded by Dunavan. All in favor, motion carried.
  - b. Clark Dietz Agreement
    - A motion was made by Dunavan to approve the Clark Dietz Professional Services Agreement, and it was seconded by Luther. All in favor, motion carried.
  - c. CPR Training
    - Luther spoke about the possibility of the county paying for all county employees to get CPR certified. All commissioners are in agreement with that.
  - d. LUCAS- Automated CPR recommendation
    - Luther spoke about the possibility of getting the LUCAS machines for each fire department.
  - e. Gateway Monument Consideration
    - Luther suggested getting a monument built that is the outline of the county when you first enter Vermillion County.
