- a. Use of Auditorium during Newport Hillclimb: Newport Church of God (Letter)
- All the Commissioner's agreed to allow the Church of God to use the Courthouse Auditorium during the Newport Hillclimb.
- b. RISE Appointment (Replace Eddie Thompson)
  - i. Thank you, Eddie Thompson

- c. INDOT Letter for SR 163 Bridge
- INDOT is wanting us to send letters from the community in support of keeping the 163 Bridge open with two lanes. The letters can be sent to Yocum.

#### X. Open Issues

- a. Mark O'Heir: Burn Ban Ordinance 2023-05
- O'Heir talks about the burn ban ordinance. Dunavan reads Ordinance 2023-05 Regulatory Open Burning for the first reading.
- O'Heir also talks about the storm that took place a couple weeks ago. They are having an after-action meeting at the Sheriff's Department on Wednesday, July 19<sup>th</sup> at 9:00 AM.
- b. Improvement Fund Application: Dale White, Western Indiana Community Foundation
- Dale White speaks about the grant application process for the Improvement Money aka ARPA Money. The Commissioner's all agree that they want to proceed with this process.

- c. Vermillion County Bicentennial (1824 2024)
- Luther would like to get a planning committee together and find someone that is willing to be in charge of this event.
- d. Union Hospital Annex
  - i. Lease Agreement
  - O Luther states this agreement had been forwarded to the Commissioner's. It's a three-year lease agreement. All the Commissioner's agree to the lease agreement. Dunavan does state he is still reviewing it and he would have his commits to Luther by Thursday.
- e. Courthouse Annex Project Delivery
- Yocum states that he should have the total cost of the Annex within the next week.
- f. County Highway Organization
  - i. County Asset Management Plan Status
  - O Luther states that the road miles have been updated between the county LTAP and INDOT. It has been given to the county superintendent. He will share it with the foreman. Luther also would like the other Commissioner's to review it as well. Luther also states that he would like to present this plan in town meetings.
  - ii. CCMG 2023 Bids Analysis & Status
    - 1. RPE

    - Luther makes a motion to approve the Rieth-Riley Construction Co, INC bid pending funding. Dunavan seconds the motion. All in favor, motion carried.
    - 3. Bridge 31
    - Still pending
  - iii. Engineer Status w/ Parke County
  - O Yocum states that he has a meeting with Jim Meece on Thursday about the sharing of an engineer. Luther also states that he has talked to Meece and they have met with another county that shares engineers. ITAP also told Luther that they would help identify an engineer or help get the positioned advertised. They are thinking it could cost around \$130,000.00 including the \$80,000.00 from state funding.
- g. Document, Scanning, Recording, Library Services
- Luther states that SBS Portals did sign the county MSA.
- h. Misc. County Properties and their classifications
- Dunavan states that a lot of these first ten parcels are little pieces of land that are next to roads. Luther suggests that moving onto the next list of properties that aren't slivers of land next to the road. Dunavan states that he will get working on the next list.
- i. Advertisement of Community Events
- Yocum states that he has been in contact with the Indiana Visitors Tourism Bureau about listing some of the county events in the publication they put out. A list of events has been created and it would depend on the funding on how many events will be able to be published. The Commissioner's agree to allow Yocum to make the decision on what events can be published.
