- VII. Economic Development Update
  - Heber states that the fourth Monday of each month is office hours for aspiring entrepreneurs or businesses within the county that would like to meet with the Small Business Development Center. This is a free service. They will be located at the Economic Development office from 11:00 AM to 4:00 PM. Heber also mentions the bicentennial celebration which is happening at the end of April. The local fourth graders will be coming to the courthouse on April 26<sup>th</sup> for the celebration. They will be writing letters to their future selves and placing them in a time capsule that will then be buried and opened back up in 50 years. On Saturday April 27<sup>th</sup> the bicentennial celebration will be open to the public and take place at the courthouse. It will be from 9:00 AM to 1:00 PM. Their will be displays throughout the courthouse, including a wax museum completed by the high ability students at Van Duyn. Also, the Community Foundation gave a grant to pay for the t-shirts and coins for each of the fourth graders, teachers, and principals.

  - b. Clark Dietz
    - i. Task Order 7 Approval: CCMG 2024-1 Bid and Construction
    - Luther makes the motion to approve task order 7 from Clark Dietz regarding the CCMG 2024-1 Bid and Construction. Dunavan seconds the motion. All in favor, motion carried.
    - ii. Task Order 8 Approval: Highway/THRIVE Centerline Miles Update
    - The Commissioners discuss task order 8 from Clark Dietz. They agreed to table this task order until the next meeting so a little bit more research can be done.

- c. Solid Waste & Soil and Water: Eric Shideler
  - i. Solid Waste Update: Shideler announces that if would like to make sure that everyone knows about the County Clean Up Days. He would also like to purchase a laptop through EAS for Solid Waste for the purpose of placing QuickBooks on it so they can keep the Solid Waste accounting electronically. The Commissioners agreed to have it placed on the Comptrollers computer in the Auditor's office instead of getting a separate laptop just for solid waste.
  - ii. Soil & Water Update: Shideler explains that he has talked to the E911 Director and he has split the annex in half so that it has a suite A and suite B for address purposes. The Public Defender's office is going to be located in the annex under Suite A and Soil and Water will be located in Suite B. He also mentions that water sample kits will be available for pick up by June 1<sup>st</sup>.
