 - a. Vermillion Trails Alliance Update: Becky Holbert & Les Zimmerman
 - Zimmerman comes to talk about the BNO trail. After a year of negotiations with US Fish and Wildlife regarding an easement that they had on a piece of property that the trails alliance needed so they could put a bridge in and continue the trail. They were able to work out an agreement to swap easements. Zimmerman states that a survey was done and on December 4th they were able to bring the documents to the Auditor & Recorder's Offices to get them recorded. US Fish and Wildlife released the easement on the triangle piece and recorded the easement granting them an easement on the piece that the VTA currently owns because US Fish and Wildlife said it would be best not to have to deal with a government entity. The next steps are needing to purchase two pieces of properties on is from Swinford Farms and the other is from Keith Little Farms. They would like to use Jon Spurr to do the property transfer. Luther makes the motion to have the county attorney assist the VTA with the property transfers. Dunavan seconds the motion. All in favor, motion carried.

The contract that has been presented can be canceled with a months' notice. Luther makes the motion to approve this contract as a task order under the current MSA with BCS. Yocum seconds the motion. All in favor, motion carried. Yocum is going to be the contact for BCS.
- d. 2025 County Insurance Approval: George Smith
- Smith with MJS Insurance comes to get approval for the 2025 county insurance. Smith states that workman's comp is based on the amount of payroll so as long as it goes up workman's comp will go up. Smith also suggest maybe having the risk control gentleman with ASTRA come back out and give ideas on what the county can do to help keep risks low. They just did the highway department a few months ago. Smith does recommend getting together with the Commissioners after the first of the year to discuss recommendations to help lower the county insurance.
