## Vermillion County Commissioners Meeting Agenda

- I. Call to order. The Vermillion County Commissioners convened in a regular meeting at 8:15 a.m. on Tuesday, December 27, 2016.
- II. Roll call. Members present were President Tim Wilson, Harry Crossley, Tim Yocum, Chief Deputy Auditor Amy Tolbert, and Attorney Jon Spurr. Auditor Phyllis Orman was absent.
- III. Approval of minutes from last meeting. Crossley made a motion to accept the minutes from December 13, 2016, seconded by Yocum. Motion carried.
- IV. Approval of Claims and Payroll. Crossley made a motion to accept the claims and payroll for release on December 30, 2016. Motion carried.
- V. County Treasurer's Report. Wilson acknowledged receipt of the County Treasurer's Report.

## VI. Open issues

- a) Property for walking trail. Yocum said they are still waiting on the final prints from the railroad company.
- b) Jail water pressure, geothermal, energy savings. Yocum said the prints are approved, they will work with Vermillion Rise to work out the details and then they will be able to bid it out.
- c) Eugene covered bridge abutment. Nothing new to report.
- d) Technology Coordinator. The position was advertised. We have not received any applicants yet.
- e) Health Insurance. Nothing new to report.
- f) Political signs on county property. Ordinance 2016-009 reads that no political signs maybe be posted on the Courthouse Square in Newport, Indiana. Wilson made a motion to allow, seconded by Crossley. Yocum opposed. Motion carried.
- g) Lease agreement for county owned property behind jail. Spurr to insert legal description and then Tolbert will mail it to Hollingsworth.
- h) Grant Writer. Yocum said they don't need a grant writer, they need elected officials to find projects they are interested in doing. They need to get proactive. Wilson asked about the Community Crossings Grant money and Yocum said he expects it any day now. He said he and Tolbert are also looking for answers for the \$220,000 match that that came from the road repairs already done.
- i) Vermillion Rise. Yocum asked if the money for the spec building has been paid out and Tolbert said it went out on December 16<sup>th</sup>. Tom Milligan said they have put the road work on hold due to the weather. He said they are proceeding with the sewer work. He also stated the marketing packaging has been mailed out. He said Southern Power is moving forward. He also said there will be another announcement next year and staffing changes are coming.
