COUNTY ORDINANCE NUMBER 2020–13 Fall 2020 COVID Ordinance Vermillion County, Indiana

AN ORDINANCE REIMPLEMENTING COVID-19 RESTRICTIONS AND MOVING CARES ACT FUNDING INTO THE GENERAL FUND.

WHEREAS, The Board of Commissioners of Vermillion County, Indiana has been advised that there has been a resurgence of COVID-19 cases in Vermillion county and that restrictions on the use of public buildings under control of the County Commissioners is necessary to protect citizens of Vermillion County.

NOW BE IT ORDAINED AND ENACTED by the Vermillion County Commissioners that:

SECTION 1. That during the COVID-19 Pandemic of 2020 the Governor issued an order requiring that masks be worn in public.

SECTION 2. That the Board of Commissioners of Vermillion County has a duty to all persons coming into the County Courthouse and other public buildings and that many people are required for various reasons to come into the courthouse and do not have a choice to stay home.

SECTION 3. That the Board of Commissioners of Vermillion County orders that for the safety of the public and all persons coming into the County Courthouse that everyone entering the County Courthouse shall wear a mask that covers their nose and mouth when they are in the public areas of the courthouse to help prevent the spread of the COVID-19 virus.

SECTION 4. That Courthouse Deputies are authorized to deny entry to persons not wearing a mask or to remove persons from the courthouse who do not keep their mask on in public areas. Further, Courthouse Deputies are authorized to bar any person from entering the courthouse if they are visibly ill or have a fever. All persons entering the courthouse shall submit to an inspection by courthouse deputies to determine if they may present a risk of infecting others with COVID.

SECTION 5. That each individual office holder may decide their own policy for masks in the non-public areas of the courthouse that are under their control.

SECTION 6. That this ordinance applies to everyone equally including elected officials, lawyers, law enforcement officers and people who don't believe masks work. It is meant for equal protection and courtesy for all citizens who need to come to the courthouse.

SECTION 7. That it is strongly suggested to office holders that they limit the business of their offices to only what is essential, limit visitors to appointment only and to question

potential visitors as to whether or not they can wait until the pandemic has passed. It is suggested that office holders allow employees to work from home when it is possible.

SECTION 8. That monies received through the CARES ACT shall be moved to the general fund.

SECTION 9. That maintenance and custodial staff are instructed to take such measures as are deemed necessary to clean and disinfect the courthouse including working overtime if necessary. Office holders are encouraged to take steps to clean and disinfect their own workspaces.

SECTION 10. Should any section, paragraph, sentence, clause or phrase of this Ordinance be declared unconstitutional or invalid for any reason by any Court of competent jurisdiction, such provision shall be deemed severable and the remaining portions of this Ordinance shall remain in full force and effect.

SECTION 11. All ordinances or parts of ordinances or resolutions that are inconsistent with the provisions of this Ordinance are repealed to the extent of such inconsistency.
